Summary: Most Big Ten offices of academic governance are led by a full-time staff Office Director who reports to the chair of the Faculty Senate, or are led by the President of the Faculty Senate. MSU is an outlier in terms of having Office of Acad Gov led by a faculty person other than the chair of the Faculty Senate, and having that person report to the Provost rather than faculty reps. We are also an outlier in terms of having low support staff FTEs per faculty member represented. Staff or faculty can get certification as a Nationally Accredited Parliamentarian.
