### **Graduate Instruction, Employment, Mentoring Subcommittee**

- 7. \*Request to Change the Requirements for the **Doctor of Osteopathic Medicine Degree**. *APPROVED*
- 8. \*Request to Change the Requirements for the **Doctor of Philosophy Degree in Chicano/Latino Studies**. ONLY THE "SSC" TO "CLS" CODE CHANGE. <u>APPROVED</u>
- \*Request to Change the Admission Criteria for the Production Medicine Scholars Admission
  Pathway and the Requirements for the **Doctor of Veterinary Medicine Degree in Veterinary**Medicine. APPROVED
- 10. \*Request to Phase Out and Discontinue the Master of Arts Degree in Counseling. (*DISCUSSED*)

Motion approved to permit Robbie Steward to speak after the College of Education presentation on the discontinuation of the MA in Counseling.

M. Sedlak presented the COE rationale, data collection, consultation process and decision to request the phase out and discontinuation.

Not just one criterion was used for this decision:

- a. 11 other programs in MI (7 are accredited)
- b. Contracting field (K-12 budget)
- c. Evolved firm 'school' counseling to a broader field agency and community settings.
- d. No research funding, although are opportunities bottom of COE list.
- e. Little connection to other programs in COE.
- f. No service courses.
- g. Costly high faculty/student ratios needed for accreditation

Sixteen TS faculty positions needed to be eliminated to reach budget needs.

Not across-the-board, but rather investing in priority areas.

G. Troia added – Dean Ames made herself available to everyone – faculty and students to discuss the recommendations and data.

CAC has two (2) representatives from each department.

- **Q:** How many faculty salaries are 'saved' by closure?
- A: This is a <u>full</u> plan for the college not just tied to <u>this</u> program. Have been shrinking this program over the years (closed PhD major six (6) years ago).
- **Q:** K-12 trying to hire counselors who are also licensed as teachers. Who has programs that combine these?

A: Cass Book – some are done through certificates, but Michigan requires certification.

MSU placements of these students are <u>not</u> intoK-12. They are not certified as teachers.

- **Q:** Transfer programs to SSC/SSW or Psychology?
- **A:** Could be transferred, but would need to budget it elsewhere.
- **Q:** What is the research expectation for faculty?
- **A:** Ten percent (10%) of the average of college \$/faculty. COE expects research from all faculty.

Not the same expectation based on availability, but expectation is to be "grant active".

Robbie Steward, MA Counseling Director – This is an excellent program in her view.

- o Accreditation is very strong (CACREP). Excellent outcomes, students are well monitored.
- o Placement: shifted their focus to train K-12 and adults community and agencies.
  - o Community market is larger than K-12 now (for reasons discussed earlier requirement for teacher certification.
- o Forty-four (44) students is the average enrollment pay tuition.
- o Focus on diversity, research they win awards.
- Land grant tradition

Please consider all of this in the decision-making.

No vote was needed.

Many data points used to decide. Just because research dollars are low – how does this balance with importance of good placement rates in this program?

If – faculty and students publish together, that is good, even if no money.

**Bigger Question, Philosophy** Cost of accredited programs in general – are these worth keeping across MSU? This always adds costs.
