9. Commentary for letter on retailing closures:

Segall- Concern that the decisions for discontinuing programs (especially <u>interdisciplinary</u> programs) should be lodged with a college. Colleges have narrower views in times of financial stress for mostly their college-focused units, not those that may link (strongly) outside the college. How do we value <u>interdisciplinary programs</u> at MSU when it is not obvious that colleges value them in the same way as their "core" programs. What is Provost role for MSU in attending to the <u>interdisciplinary cross-college</u> programs.

Sense of group – Unanimous support for this comment.

Question about whether these program closures <u>really</u> save money.

Question about forcing a program into a college without a good fit; then closing it a few years later. This seems not very honest.

 - a. Sousa, Lipton, Haywood 3 new departments for CHM in Grand Rapids
 - b. Questions: Would East Lansing faculty be able to have adjunct status in TSMM? Yes.
 - c. MSU basic science departments support these new departments.
 - d. Grand Rapids faculty may also want adjunct status in MSU department too.
 - e. These would be independent ("real") departments in Grand Rapids (hiring, T&P consideration, etc) need to reduce barriers between Grand Rapids and East Lansing
 - f. Graduate Students- will be in an MSU graduate program (not a PhD program in TSMM for now) on EL campus. Will the get "credit" for advising these students?
 - g. How to keep linked to EL campus wth broad outlook broader than the GR site? Have video links, expectations of connections to campuses as for any good MSU faculty member.
 - h. Guidance committee members ideally will have a set of faculty from both GR and EL
 - i. The opportunity is great for Grad School- the translational science arena is popular and fundable.
 - j. Anesthesia also a new department (Dean Mundt was not given a courtesy call) What is the link to college of Nursing MS in Nurse Anesthesia?
