Fringe benefit rates for GA's are affected by the large number of 999 credits taken in excess of the 24 that are required -Revising policy on embargoing theses and dissertations: Documents are currently deposited in ProQuest (MSU documents are not searchable by Google, not available to Third Party Sellers). If patent is possible, embargoed for 6 months before submission but the student can still graduate. Tony Nunez would currently prefer that these are held by Proquest. Another issue: should there be other reasons that Theses or Dissertations be embargoed? Some students and programs wish that research was available. Currently all on or all off. The committee will discuss this more. UGC Members were encouraged to speak to their colleagues about this issue and report back.
