7. *Requirement for a Second, Joint or Dual Master's Degree

A candidate for a second master's degree, or for joint or dual master's degrees, from Michigan State University may request the application of up to 9 credits, appropriate to both programs, from the first master's degree program to the second or from one master's program to another. These 9 credits must have been earned within the time limitations of the college concerned. Credits used to satisfy the requirements of one master's degree may not be used to satisfy the residency requirements of another master's degree. The candidate must obtain written approval from both programs indicating which 9 credits will be shared. ADD: FOR MASTER'S DEGREE PROGRAMS OF MORE THAN THE MINIMUM 30 CREDITS, ADDITIONAL CREDITS MAY BE SHARED UP TO 30% OF THE TOTAL CREDITS REQUIRED FOR EACH MASTER'S DEGREE PROGRAM.
