Professor Pivarnik submitted a report on the activities of the Research Integrity Office to UCGS and to Steven Hsu. Generally, universities that receive federal funds have Research Integrity Officers. The office received five new cases this year, a number lower than previous years. The quality and dispersion of cases was typical compared to previous years. The process involves a preliminary investigation and then, if the case merits, a full investigation. The office is available to present to all groups involved in the research process, including undergraduate students, graduate students, and faculty. Terry Curry and Bill Beekman will coordinate the reappointment process.

7. University Committee on Graduate Studies Subcommittees

Curriculum and Program Review Committee (Reed):

The committee recommends bundling agenda items 8 and 9. The committee is in the process of discussing transfer of graduate certificate credits to doctoral programs. The current language is vague. The committee generally supports that credits should be transferable with approval of the student's guidance committee. The chair expressed the committee's concern that doctoral guidance committees would be the sole and final arbiter of what transfer credits were accepted. The chair also expressed

concern about linked B.A./M.A. programs. The MSU Registrar's Office reports that a student in a linked program may only transfer credits that were taken after that student was enrolled in the linked program.

Academic Research Policy Subcommittee (Nair)

This subcommittee is in favor of research policy changes in revised MSU Patent Policy. The subcommittee chair will write a summary of the discussion about the revised Patent Policy and will forward that summary to Richard Chylla.
