The Steering Committee as forwarded a series of pertinent issues different governance committees might want to address. One issue presented was the evaluation of traditional and online courses. - 4. Remarks from the Dean of the Graduate School (Stoddart):
 - Update on Responsible Conduct of Research and Scholarship.

The Graduate School is co-sponsoring a workshop with the Academic Advancement Network on advising graduate students at MSU. This workshop is aimed at new faculty, specifically attracting and retaining graduate students and facilitating grant applications.

Subcommittees should meet and provide an update on subcommittee projects. The Dean hopes to meet with the subcommittee chairs and set priorities. The Graduate School can help schedule meetings.

- 5. Remarks from the COGS Representative (Jordan):
 - Encourage students to submit abstracts for the 9th annual Graduate Academic Conference. This conference gives graduate students an opportunity to practice conference presentations. This year's conference has an emphasis on inter-disciplinary research. The conference organizers design sessions to mesh different disciplines.
 - The Graduate School sent out Call for Proposals. COGS is asking UCGS members to encourage graduate students to participate. This is a free conference with cash awards. COGS will forward information to Chris Hogan to send to faculty members on UCGS.
