The meeting was called to order at 3:02 p.m.

- 1. Approval of Agenda as distributed: Motion to approve, seconded, and carried.
- 2. Approval of January 9, 2017 Minutes: Motion to approve, seconded, and carried.
- 3. Remarks from the Chairperson (Hogan):

No remarks other than noting Terry Curry and Bill Beekman will join us at some point during the meeting to discuss the review of the Research Integrity Officer.

4. Remarks from the Dean of the Graduate School (Stoddart):

Dr. Stoddart noted there have been several questions from students and faculty related to executive orders on immigration. Students should be advised to refer to the latest information on the MSU Office for International Students and Scholars' (OISS) website.

5. Remarks from the COGS Representative (Jordan):

COGS received a significant number of abstract submissions for the 9th annual Graduate Academic Conference to be held Saturday, February 25th. The theme is "The Intersections of Inclusion and Interdisciplinary Research." It will be held in the MSU Union, and Dr. Eva L. Evans, History Maker and former Lansing Public Schools Superintendent, will deliver the Keynote address. Saturday, March 18th, is the 3rd Annual Diversity and Sensitivity Workshop: "Diversity isn't just Black and White." It will be held in the International Center, Room 115. It includes a diverse panel of faculty and staff around MSU. Dr. Chezare Warren will deliver the Keynote address, and the Transforming Theater Ensemble will perform a play on implicit/unconscious bias.

6. University Committee on Graduate Studies Subcommittees

Curriculum and Program Review Committee (Wittenbaum on behalf of Reed):

The subcommittee approved the three curricular items: 7, 8 and 9. The full committee then also voted to approve. Dr. Wittenbaum then presented the current and proposed language related to MSU's policy on transfer of credits from graduate certificate to graduate degree programs. The committee discussed, and the subcommittee will bring back a final proposal to the full committee at the next meeting.

Academic Research Policy Subcommittee (Nair)

The subcommittee has been tasked with considering the process for approval of graduate committee members who are either outside of MSU or are not "regular" MSU faculty members. There was discussion among the full committee about whether there is a need to obtain letters of recommendations for these outside committee members, as is currently required by MSU policy. The subcommittee will consider the input from UCGS to draft a recommendation for our next meeting. The subcommittee has also been tasked with considering whether outside committee members should be required to make conflict of interest disclosures (currently not required under MSU policy). The subcommittee would first like to meet with legal counsel before they discuss further.

Graduate Instruction, Employment, Mentoring Subcommittee (Poindexter)

The GIEM subcommittee also discussed the process for approval of graduate committee members who are outside of MSU or are not "regular" MSU faculty members. GIEM will summarize its discussions and recommendations and provide that summary to the Academic Research Policy subcommittee, which will then bring forth a recommendation.
