I. Call to Order, Welcome, Introductions

A regular meeting of the University Committee on Student Life & Engagement was held on September 23, 2022, at 8:32 via Zoom.

Host Allyn Shaw presided.

II. The agenda was approved as distributed.

III. The draft minutes of the April 15, 2022, meeting was approved as distributed.

IV. Presentations:

Anthony T Williams, Jr. presented Student Rights & Responsibilities (SRR) and General Student Regulations (GSR).

New conduct policy & procedure to expand the definition of student organizations to include on and off campus behavior.

Prior policy was to include only Registered Student Organizations, now expanded to include all student organizations, registered organizations and non-registered, on and off campus organizations.

Dean Williams also commented that MSU solicited proposals for consultant expertise to assist the university in reviewing and rewriting the university's SRR and GSR. Huron Consulting Group was selected. There will be an advisory group, list of names on



that group will be shared, and monthly updates. The timeline goal of the Code of Conduct adoption is 3/23 -5/23.

Dean Williams stated that the final policy will be presented through all government bodies to get approval before being finalized.

- V. Heather Shea presented Student Reproductive Rights and Resources Campus Action Network Update. Link to power point that Dr. Shea presented was shared in the chat box.

- VI. Su Webster presented the 2022 address compliance. Su shared a link to MSU policy that states when a student changes their address it must be updated within 5 days. Students must update address changes to avoid hold on account. Deadline to update address changes is October 17th, 2022.
